RULES AND REGULATIONS GOVERNING THE HUNTING OF WATERFOWL ON GLENN FLINT LAKE

1. Twelve waterfowl hunting permits (and an unlimited number of alternate permits) will be issued pursuant to lottery for the 2017-2018 waterfowl season. Permits will only be issued to persons complying with the lottery rules (one hunting permit per launching permit per boat). The permit is non-transferable and must be in the possession of the permittee while hunting. A maximum of two guests may accompany the permittee on any hunt. Permittees are responsible for the actions of their guests.

2. Each permittee will rank their choice of the twelve available locations on their application. Based upon the results of the lottery, the twelve selected permittees will be assigned a location based upon the rank assigned the locations by the permittee on his/her application. A successful applicant that fails to rank all blinds will be assigned one by the Hunt Coordinator. The permittee agrees to hunt within fifty (50) yards of the assigned location (except for stakes K, L, and C where the permittee may hunt within 75 yards of the stake). No permanent (affixed to ground or trees or not readily removable) blinds or cutting of woody vegetation is allowed but hunting from water's edge (i.e., outside your boat) is permitted. If a staked hunting site is not occupied by 6:30 a.m. for a morning hunt or 3:30 p.m. for an afternoon hunt on any given day, it may be occupied for such morning or evening by an alternate (in the order that the alternate arrived at the launching ramp) and, if not so occupied by an alternate, then by another permittee (in the order arrived at the launching ramp). Note that a blind is considered occupied when its occupant(s) has indicated their intent to use that blind by hanging their provided blind card on that specific blind indicator on the blind box located at the boat ramp. All hunting parties must launch from the Glenn Flint Launching ramp (i.e., there will be no walk-in hunting or set-up). If the lake completely freezes over no hunting will be permitted.

3. The lake has been zoned in order to provide (a) maximum safety for the people that live or own property adjacent to the lake, (b) to assure the safety of hunters and fishermen, and (c) avoid the need to close the entire lake to fishing during the waterfowl season. Accordingly, there will be no loaded gun in any restricted area (including the launching ramp). Fishing and boating is permitted in non-hunting areas. Crippled waterfowl may be retrieved from non-hunting areas, but firearm use is absolutely not allowed. Remember, it is a violation of law to fire a gun from a boat moving under mechanical power.

4. Hunting for waterfowl only will be allowed during the legal shooting hours for the days/dates set forth for the Central Zone. Please note that seasons and bag limits have changed notably from prior years. Also, be aware that the days/dates set forth below do not include all of the dates permitted by law for hunting certain species.

Note: The first day Glenn Flint will be open for waterfowl hunting will be Saturday, November 24th.

Hunting days will be restricted to Tuesdays, Wednesdays, Saturdays, and Sundays only. Violation of this rule will be cause for revocation of this permit.

Duck Season Nov. 24, 2018 - Jan. 13, 2019

Canada Goose Season Nov. 24, 2018 - Feb. 10, 2019

5. Each permittee will, at the close of season, provide, upon request, the district with an accurate list of the species and number of waterfowl taken during the season.

6. All state and federal waterfowl and boating laws and regulations, and the Rules and Regulations Governing the Hunting of Waterfowl on Glenn Flint Lake are in effect and will be enforced. Violation of any of these rules or state or federal laws or regulations governing waterfowl hunting will be cause for the revocation of the permit and may result in other civil or criminal legal action. These rules may be amended at any time or from time to time by the district upon written notice and/or notice posted at the launching ramp.

7. Each permittee, for him/herself (including the heirs and estates thereof) and on behalf of his/her guest(s), agrees (a) to defend, indemnify and hold harmless, the district, its officers, members, employees, agents including the Hunt Coordinator(s), consultants and officers from any claim or action arising out of any acts or omission of such persons or in any way related thereto, including the acts or omissions of other permittees and (b) agrees that the provisions of the Indiana Recreational Use Statute (Ind. Code §14-22-10-1, et seq. shall govern the parties'; provided, however, that a permittee's purchase of a launching permit from the District shall not constitute "monetary consideration" for purposes of the application of that statute. Each permittee is aware of the risks inherent in these hunting and boating activities and freely assumes such risks.

9. Permittee acknowledges that the privilege of hunting waterfowl on the lake depends upon the behavior of permittees and their guests. Be a good sportsman. Avoid any occasion for conflicts with residents and/or fishermen. Disputes between permittees will jeopardize this program, so resolve or avoid them. Permittees may be required to attend an orientation meeting.

10. The Application for Drawing for Permits must be scanned and emailed. Applications must be received no later than **Thursday, November 1**st. The lottery will be conducted at 4:00 p.m. on November 14th at the boat ramp. Results of the draw will be will be sent via email. Blind Cards and Hunt Permits will be mailed after draw. No one need be present at the drawing to participate.

11.) Absolutely no application will be accepted later than stated dates above. Applications presented at draw will not be accepted.
